**NOTIFICATION**

Application are invited from the eligible candidates for the post of Dean cum Director, Shimoga Institute of Medical Sciences, Shimoga , as per the Government order: MED 287 MPS 2022 dated: 12.07.2022. The Minimum Educational Qualifications and eligibility criteria for the Dean cum Director post shall be as per the NMC/MCI norms and Bye-laws of Shimoga Institute of Medical Sciences, Shimoga.

**Eligibility Criteria:-**

1. The candidate shall be selected from amongst the Professors of Shimoga Institute of Medical Sciences, Shimoga on Seniority and Merit basis.
2. Should possess the recognized Post Graduate medical qualification and other academic qualification from a recognized medical institution with a minimum of 10 years teaching experiences as Professor / Associate Professor / Reader in a Medical College / Institution, out of which at least 05 years should be as Professor in a Department.
3. Candidates for the said post shall be selected based on seniority cum merit form amongst the teachers in the same autonomous institution i.e. Shimoga Institute of Medical Sciences, Shivamogga
4. 05 senior most willing Professor as per the cadre wise seniority list of professors shall be considered by the Governing Council for the said appointment.
5. Candidates shall have administrative experience either as Medical Superintendent or as Head of the Department or as Professor at least for 05 years.
6. Candidates shall satisfy Medical Council of India/National Medical Council norms for appointment to the said post and norms prescribed in Bye law of the Institution.
7. Maximum upper age limit for the said post shall be 02 year earlier to superannuation. i.e. should not have completed 58 years as on the last date for submission of the application.
8. Candidate's probationary period must have been declared.

**Method of Selection:-**The method of selection shall be on the basis of merit. The merit is assessed on the basis of the performance of the candidates and the marks obtained in the interview, as prescribed in Bye-law.

**Pay Scale:-**Rs. 1,44,200-2,18,200 with applicable allowances as per AICTE scale.

**Period of appointment:-** Maximum four years from the date of appointment or as Bye-laws of Shimoga Institute of Medical Sciences, Shimoga or until further Government Order whichever is earlier.
